**CUSTODIAL TRANSFER**

**WEST CENTRAL SOLID WASTE DISTRICT**

The Council approved \$55,043.12 to be paid to West Central Solid Waste District for 2021.

The motion was made by Phil Gick and seconded by Danny Wallace. The motion carried.

**PUTNAM COUNTY LIBRARY DECLARATION OF FISCAL BODY**

Phil Gick made a motion to sign the declaration of Fiscal Body, making the Putnam County Council the Fiscal Body for the Putnam County Library, Danny Wallace seconded the motion. The motion carried.

**BOARD REPORTS**

Danny Wallace said that they had met with Operation Life Board and they will leave \$50,000.00 with the Operation Life Board and transfer the remaining \$120,000.00 to \$130,000.00 to the county.

Highway- Rick Woodall said that the revenue is down 6% for the year. They have double chip and sealed 3 roads.
