#### **COMMISSIONER UPDATE**

Commissioner, Rick Woodall updated the Council on several issues.

Rick said that EMS has uncollected debt in the amount of \$1.8 million dollars.

Rick also said that the response times have been reduced and the average runs are approximately the same. The EMS building has extensive mold issues. Rick said that they would be having a meeting with the Operation Life Board to recover the revenue that is left and owed to the county.

The Highway revenue chart was distributed and it was decided that no chip and seal roads will be completed in 2020.

Putnam County will owe West Central Solid Waste District \$55,043.00. Montgomery County has decided to not be a participant in the District.

Rick Woodall also gave the Council an update on the County Health Insurance.
