**NEW COUNCIL MEMBER**

The Council welcomed the newest member to the board, Jay Alcorn. He replaced Jill Bridgewater who resigned.

**EXTENSION OFFICE**

Mark Evans passed out the 2020 impact report. He also came to the meeting asking for a consensus of approval on transferring money from his part time help line item to Kim Beadles' salary. He has looked at his part time budget and feels he can reduce it. If the Council approved the transfer of funds; he assured them he would not be coming back at-a-later-date asking for more money for part time help.

Currently Kim Beadles was a shared position between Soil & Water and the Extension Office making it a full-time position. Soil & Water contributes \$9,975 and currently the Extension Office contributes \$18,566. He would like to increase the amount contributed by his department by moving money from the part time help line item. He was not asking for any new monies. He felt Ms. Beadles deserved it because she works nights and weekends and the other position in the office makes \$35,000 a year. Mr. Evans felt the salaries needed to be more comparable.

The Council's consensus was in favor of the transfer. Mr. Evans was to get with the Auditor's Office to get the paperwork to fill out and submit at their June meeting.

**ASSESSOR'S OFFICE**

Assessor Janet Brown came to the meeting requesting to hire someone part time. She has a lady getting ready to go on maternity leave for three months. She would only be paying her for one month. This would leave money in the account to hire a part time individual for the three months her employee was on leave. Phil Gick made the motion to approve. Larry Parker seconded.
