The position would not have any benefits except for PERF, a document would be signed by the employee acknowledging. The salary and benefit would be paid from grants and user fees only. If there is a time where there was not enough money to pay for a full-time individual it would revert to part time. Keith Berry made the motion to approve the request of moving position to full time. No county funding would pay for the salary or benefits. Employee needed to sign document acknowledging position did not come with benefits. Larry Parker seconded. The motion carried unanimously.

**PUBLIC DEFENDERS**

Judge Headley passed out information prior to the meeting with the challenge they were facing regarding public defenders. They need to go from the 2 ½ positions to 4. Judge Headley researched and they do have money to fund it for 2022. Next budget process they will have more numbers to present to the Council for moving forward. Danny Wallace made the motion to approve. Jay Alcorn seconded. Phil Gick abstained. The motion carried. Dave Fuhrman said this has been an ongoing problem for some time, the county needed to address it.

Unfortunately, COVID is not ending, they requested to continue to be paid for overtime instead of earning compensatory time. The Commissioners and Council had approved monies earlier in the year to pay for the overtime. They asked to use the balance left at the end of the year in the accounts to pay for overtime in 2022. They realize an additional could not be submitted until next month for the Council to approve.

They would also like to submit next month the ending balance for the nurse being paid from the CARES Act money. And the part time staff being paid from the rainy-day fund.

The Council could not make a motion at this time but gave a consensus to bring the appropriate paperwork next month for them to review and vote on.
