The Putnam County Council met in regular session on February 20, 2018 at 6:30 PM at the Putnam County Courthouse. Darrel Thomas opened the meeting and the pledge to the flag was given.

AUDITOR'S OFFICE

Lorie Hallett, Auditor requested approval to adjust salaries due to an employee leaving the office. Lorie told the council that in order to make the changes to the salaries she would need an additional in the amount of \$2,581.00 from the Auditor's Ineligible Homestead Fund and that it would not be able to be sustained after 2018.

Larry Parker made a motion to approve the salary adjustments as requested and Phil Gick seconded the motion. The motion carried.

Don Hatfield, Director of Planning and Zoning gave the Council an update on the business being done in the department.

Don also explained to the Council that the current Administrative Assistant will be going on maternity leave soon and the office will not be covered while he is out completing inspections. Along with the office being shorthanded, the County has assumed the responsibility to complete issuing permits and doing the inspections.

Rick Woodall, Commissioner also spoke on behalf of the Planning and Zoning Department as for the need for a temporary part-time position that will not work more than an average of 29 hours per week.

A discussion was held as to where the wages could be paid from, it was suggested that there should be enough money in the Building fund as long as the receipts continue as they have been.

Larry Parker made a motion to approve the request for a temporary part-time employee and Keith Berry seconded the motion. The motion carried.
