2024 WAGES FOR COUNTY EMPLOYEES

AUDIENCE:

Campbell stated Auditor Berish had furnished them with updated reports to review. The board went down the line of each department:

*Any county employee not making the medium salary on the revised wage report, would be brought up to that salary unless an exception is made (see below).

Clerk – with updated job descriptions, move the 3 deputies to the next tier in wage study making their new salary \$42,073. Auditor – n/aTreasurer -n/aRecorder - n/aSheriff - each deputy will receive an additional 8K pay increase. Surveyor -n/aCoroner – n/aAssessor -n/aProsecutor -n/aExtension -n/aVeteran – Veteran Officer remains at current salary and the part time position receive a 5% increase (no increase had been given during budgets). Council – increase secretary stipend to \$2,250. Commissioner – increase secretary stipend to \$4,500. Planning -n/aElection – with updated job description, move the deputy to the next tier in wage study making their new salary \$42,073. Real Estate -n/aCommunity Corrections -n/a (will need to get salary increases approved by his board) E911 – n/a EMS – Director salary change to \$81,000 and Assistant Director change to \$76,000. Custodial – n/aGIS - n/a

Superior – change office manager to \$48,000 and put the language for the bailiffs to be "up to" their salary amount. Leaving it to the Judges what they want each bailiff to make.

Adult Probation -n/a

Circuit Court – change office manager to \$48,000 and put the language for the bailiff to be "up to" their salary amount, leaving it to the Judges.

Jail – change head cook to jail officer/cook and move his position to be with the other jail officers, making salary \$47,597.

EMA - n/a

Title IVD – n/a

Highway – all salaries with "up to" stipulation to leave it up to the Commissioners how to structure each category of workers in the department.

Soil & Water – n/a

Health – go with proposed numbers from 2/5 Council meeting and add the language of "up to" in front of all the salaries.

Part time – change from up to 15/hr to up to 17/hr. Any part time employee that is currently approved to receive more than 15/hr can get an additional up to 2 more per hour.

Gick made the motion to approve the above changes in 2024 salaries. Huffman seconded. The motion passed.
